General Assembly Update from Sen. Monty Mason:

- Contentious General Assembly session from Day One
- 29% of the Dem bills in the House of Delegates passed
- 48%-48% break in the Senate pretty even
- Senate Dems stomped the bad bills that passed out of the House of Delegates
- So-called 'Recalibration' of Governor Youngkin's budget was voted down in the Senate
- Senate passed a Skinny Budget:
 - \$4.2 billion budget rainy day/reserve
 - o \$250 million to shore up VA retirement system
 - o Money to cover inflationary costs for transportation and infrastructure projects
 - \$200 million shortfall in school funding by the Governor's office Senate covered it short term to provide stability ... came from excess revenue ... so there is still a \$200 million hole
- House has been a proxy for the Governor for the first 2 years but as long as Dems hold the Senate we will control the impact... if the Dems take the House, it will be a different story entirely
- Heralded the overhaul of the workforce development system noted the state Secretary of Labor did a lot of hard work here... worked with Labor Groups and it passed unanimously
- Dominion energy rate legislation compromise bill passed unanimously in Senate and with one nay in the House
- State Corporation Commission judges vacancy still an issue 3 judge panel, 2 vacancies.

Q&A and Comments:

- John McGlennon thanks to Monty and Dem legislators for removing the educational support cap ... it will help tremendously
- Suzanne Hagedorn second the thanks for education support
 - Has a kid in York County schools and the Youngkin history SOL is a nightmare.
 Encourages everyone to comment on the SOL.
- XXXX someone asked about making Richard Bland independent
 - Monty answer: Senate is in agreement that they should be independent; but the House is in a different place (they are good people but they are in a different place)
- Jess Anderson seconds Suzanne's point re: commenting on the SOL
 - Asked Monty about the education short fall Monty responds: yes short fall still an issue; definitely encourages people to comment on the SOL but also on RGGI
- Christine Payne Sen Mason was at the forefront of the blue wall re: stopping Youngkin and GOP assaults on women's access to health care/abortion access, guns, etc.

Monty responds: Homegrown VA boy... but this is different — a six year old boy had access to a gun and shot his teacher. That is DIFFERENT. We don't know why people kill themselves but one thing we can agree on is the access to the weapon. Safe storage is the most basic thing — it's lay up stuff. Regarding women's reproductive rights, he recalled a commercial from years ago where someone in a restaurant snatches away menus from women and decides what they will eat for them. Says the point of that was that nobody would stand for that behavior when it comes to lunch, why should we let them do that with women's bodies?
